3. Return this completed form along with a **proof of purchase (Dealer sales receipt or invoice), and proof of Farm Bureau membership (copy of membership card)** in an approved state.
4. Claims must be postmarked within 90 days of purchase. All 2011 claims must be postmarked by February 28, 2012.
5. This offer is only available to the end user and original purchaser.
6. Fraudulent claim submissions could result in Federal prosecution under the U.S. Mail Fraud Statutes (18 USC, Sections 1341 and 1342).
